JD was a beloved husband, father, adventurer, wanderer and long-time student of Grand Master Park at Park's Martial Arts Academy in Billings, Montana.

JD was passionate when it came to his friends, hobbies, recreation, and music.

Martial arts was a 26-year pursuit for JD where he earned a 3rd Dan Black Belt in Judo while also dabbling in Taekwondo. He was a dear friend to Grand Master Suk Byung Park and his wife Youn Park. Here, he felt like an adopted son of Suk and Youn.

JD was an adventurer. He was an accomplished skier, a legend at Red Lodge Mountain with the nickname 'Birdman'. Floating the river with friends and family and trying new forest service cabins provided wonderful memories. In his 40s, JD took on paragliding. To say he had guts was an understatement, if he had any fear, you couldn't tell. He wasn't afraid to try something new and he was always determined to become the best at it.

JD was the guy who would drop everything to help someone. He was generous, kind and always looking out for the underdog. He participated in 40 Days for Life Prayer walks and led his family. He had a great devotion to the Rosary and would often "preach" or interact with the homeless who wandered by the Dwyer Park Grotto while he prayed. Unscripted adventures were going on wherever the spirit moved JD.

This scholarship is a celebration of JD's spirit for adventure, his heart and devotion to the martial arts and his generosity to others.

JD May Judo Scholarship Information

Judo is a sport where each opponent attempts to break the others' balance and pin. Team Judo USA describes judo as: "a tremendous and dynamic combat sport that demands both physical prowess and great mental discipline. From a standing position, it involves techniques that allow you to lift and throw your opponents onto their backs. On the ground, it includes techniques that allow you to pin your opponent's down to the ground, control them, and apply various chokeholds or joint locks until submission."

The American Jungdo Federation and the instructors at its Branch Academies are led by Grand Master Suk Byung Park. Grand Master Park is a 5 time Korean national champion, world class instructor and a former Olympic coach of the Netherlands. He holds a 10th Dan Black Belt in both Judo and Taekwondo.

At the American Jungdo Federation we believe in teaching the mental aspect of martial arts as well as the physical. Martial arts can boost academic performance and transform character. Current research not only supports this but also shows the martial arts enhances cognitive, behavioural, and social/emotional growth as well.

Our goal is to build methods of strength and self-defense for mind, body and spirit. The goal is to enhance the lives of students, empowering them to lead with confidence and courage. Our students learn to apply martial arts in competition but also in every day life.
